- **Job Description:** Primarily Teaching along with Academic, Administrative, Student Activities and Research related functions.
- **Reporting To:** Dean / Head of the Department or as advised from time to time.
- Candidates who have completed defense for the PhD before closing date for the receipt of the Application Forms will have to attach the Certificate / Notification mentioning that Candidate is declared eligible for award of PhD Degree.
- **Desirable Experience:** Minimum of one year will be preferred in Teaching / Research / Industry.
- **Desirable Requirement:** Candidate having PhD from CFTIs like IITs, NITs, IIITs, INIs etc. will be preferred. People with higher qualifications & good academic record shall be given preference.
- **Emolument:** **Rs. 1,00,000/-* per Month (PhD Holders (PhD Thesis submitted))**
Rs. 75,000/-* per Month (Non-PhD Holders)

3. **आवेदन प्रक्रिया / PROCEDURE TO APPEAR FOR RECRUITMENT: -**

- i. Candidates willing to apply for the post are requested to apply online through the Samarth Recruitment Portal by visiting the link: <https://iitprec.samarth.edu.in/>
- ii. These positions are purely on a temporary and contractual basis for a period of 11 months and may be extended only once, with a mandatory break in service, subject to satisfactory performance and approval of the Competent Authority.
- iii. Only Shortlisted Candidates shall be communicated about the mode, date and other relevant details for the interview/test. The decision of the Screening Committee shall be final in all respects.
- iv. Candidates are not required to send hard copy of the application to the Institute.
- v. Candidates should produce all the original documents in respect of all the parameters filled in the form during scrutiny on the day of Interview. At the time of verification of documents, if documents are not as per Institute's criteria or originals are not presented then candidate will not be allowed to attend Interview / candidature shall be cancelled. Hiding information or submitting false information will lead to cancellation of the candidature at any stage of recruitment.
- vi. Please bring all following relevant original certificates and their self-attested photocopies (1 set), 2 copies of passport-size photographs and the relevant certificates issued by the competent authority failing which they will not be allowed for interview.

4. **चयन प्रक्रिया / SELECTION PROCEDURE:**

- i. Shortlisted candidates will be informed through email to appear before the Committee constituted for Interview.
- ii. Selection will be made based on interviews of candidates which will be conducted by the duly constituted Committee.
- iii. The final selection will be based on performance in the personal interview.
- iv. Offer of appointment will be provisional subject to verification of original certificates at the time of joining.
- v. Only selected candidates will be communicated through email; no communication shall be done with / entertained to / from the candidate(s) who have not been selected.

5. **सामान्य निर्देश / GENERAL INFORMATION & INSTRUCTIONS:**

- i. The Institute reserves the right to terminate the candidate any time with **One Month Notice** without assigning any reason thereof.

- ii. **The Institute reserves the right to reject any/all application(s) and/or cancel the advertisement in whole or in part without citing any reason at any stage of processing.**
- iii. No TA/DA and/or Lodging/Boarding will be paid for attending the Interview OR Joining. No accommodation shall be provided.
- iv. Candidates are advised to fill in the information carefully on the application form. The institute will neither be responsible for any wrong information furnished by the candidate(s) nor accept any subsequent requests for making any corrections. The candidate(s) shall be solely responsible for the information filled in application form. No change/deviation, whatsoever, will be entertained.
- v. The candidates are required to have at least one working email and Mobile Number which will be used during the entire selection process for communication, if required.
- vi. Any modification/correction/addition etc., if any, related to the Advertisement and/or related to the recruitment process will be uploaded on the Institute website only. - xi. The Institute shall verify the antecedents and documents submitted by a candidate at the time of appointment or at any time during the tenure of the service. In case, it is detected that the documents submitted by the candidates are fake or the candidate has a clandestine background and has suppressed the said information, then his/her services shall be terminated, and legal action may be initiated against such candidates/employees at their cost of consequence.
- xii. The Institute reserves the right to assign / transfer the selected candidate to any section / department within the Institute.
- xiii. In case of any dispute regarding the Recruitment Process, the decision of the Director, IIITP, shall be final. In case of any Legal Dispute regarding the Recruitment Process, the place of jurisdiction shall be Pune, Maharashtra (India) only.
